First Gross/ Gen Path Course Shines in Sunny St. Pete

During the second two weeks in July, over 90 participants converged on beautiful St. Pete's Beach for the first annual combined Gross and General Pathology Meeting sponsored by the C.L. Davis Foundation and our perennial co-sponsor, the Armed Forces Institute of pathology. The weather was wonderful, the water was warm, and the participants saw more of them than they would have expected, even with ten-hour days.

"Long but survivable days" said one review, and most of the others for this eight-day course agreed. With shrinking pathology budgets at many veterinary schools, the Foundation combined two of its flagship courses, the Gross Morbid Anatomy of Diseases of Animals (now in its 35th year), and the General Pathology Review Course, to make a single eight-day intensive review.

Classroom days ran from early (8AM) to late (10PM), but with a full hour midday lunch, and two hours prior for dinner, many participants found at least some time to jump in the surf, dip in the pool, or soak up some much-needed sunshine. Some kindly instructors even finished a few minutes early so participants could enjoy the beautiful confines of the Sirata Beach Resort for a few precious minutes more.

The first four days of Gross Pathology featured three new speakers, including Dr. Scott Terrell of Disney's Animal Kingdom Park, who won this year's Samuel W. Thompson lectureship award, as voted by the participants for the best lecturer. "It's important to bring in fresh young speakers," said course director Dr. Bruce Williams. "New talent is hard to find and speaking for three to four hours on any topic is not easy for most pathologists".



A tried-and-true crew followed for the gen path section of the course, however. Authors from the first edition of McGavin and Zachary's *Pathologic Basis of Veterinary Disease* and others once again reviewed their chapters for the assembled participants, as well as hitting new developments and even some important recent articles in their areas of specialty.

The Foundation would like to congratulate the assembled participants and staff for not only enduring the grueling 80+ hours of CE with good cheer and a bit of 45 SPF, but finding time to renew old acquaintances and discover new restaurants in the Tampa/St. Pete area.

Plans are underway for next year's meeting from 10-18 July 2011, so block out your calendars now!

Descriptive Course a Huge Hit in Virginia Beach

In June, the Davis Foundation co-sponsored the AFIP Descriptive Veterinary Pathology Course, Current Lab Animal Science Seminar (CLASS), and Pathology of Laboratory Animals (POLA) Course. For many (especially the long-time faculty of the Descriptive Course) it was a bittersweet moment. In 2011, the AFIP will close under the Department of Defense's Base Reallocation and Closure law, so this will be the last official course of this type under the aegis of the Armed Forces Institute of Pathology.

"Let me start by saying that these courses will not disappear", states Foundation President Dr. Bruce Williams. "They are fantastic courses, and fulfill a tangible educational requirement for veterinary pathologists around the world. The Foundation will gladly continue these courses into future years, and will make every attempt to continue the AFIP's tradition of quality."

These courses have an amazing history, as well. This year marked the 54th edition of the POLA Course, the 17th of the Descriptive Course (now given annually in the US, Europe, and India), and a full decade of the CLASS course. "The simple fact that POLA draws a huge crowd after a half century attests to its enduring quality, and this year's course, was no exception. 2010 also marked a first for these courses. "Due to last year's poor economy, we tried something new. Combining these courses gave the attendees more bang for their buck – eight full days of RACE-accredited, focused CE for less than a thousand dollars is pretty well unheard of today," said Dr. Williams. The attendees recognized this as well, with over 90 participants for the Descriptive Course as well as over 110 for the POLA Course.

The last official AFIP POLA Course was special in another way, at least to its faculty. "With only one exception, all of the speakers trained at AFIP - and the other was a visitor. I think there is some symmetry in that", opined Dr. Williams. "Moreover, three of five Descriptive Course faculty had been training officers at AFIP, and another is the current department chair. For all of us, it was a moment frozen in history, and not one we will ever forget."

Beginning in 2011, the Foundation will take over sole sponsorship of these courses. Look for the Descriptive Veterinary Pathology Course, an expanded CLASS, and POLA to be back in Virginia Beach next June.

Seats are still available for this year's European Division meeting in Belgrade, Serbia from September 6-8, 2010. It's a great program that you don't want to miss!! For more info, see brochure on page 8.

**Veterinary Anatomic Pathology Residency Training
with Graduate Research Opportunities**

The Department of Microbiology, Immunology and Pathology, in the College of Veterinary Medicine and Biomedical Sciences at Colorado State University is offering post-DVM graduate training positions in anatomic pathology. The core program includes residency training in veterinary anatomic pathology and graduate research. The program is designed to culminate in specialty board certification and granting of MS or PhD degrees. Residency training is facilitated by a diverse faculty, 18 of whom are ACVP, ACVM or ACLAM board certified. Graduate research opportunities include, but are not limited to, the study of bacterial and viral pathogenesis/therapy, mycobacterial diseases, arthropod borne infectious disease, retrovirus pathogenesis/therapy, transmissible spongiform encephalopathies, epidemiology, immunoparasitology, malarial immunology, vector biology, ecological parasitology and cancer or radiation biology. The first three years of residency and graduate training are supported by state funded stipends starting at approximately \$32,500/year. NIH sponsored training grants and successful applications for extramural funding support subsequent graduate research. Benefits include paid tuition and contributions to student health insurance. Applicants must have a DVM or equivalent degree from a College of Veterinary Medicine/equivalent. Applications for positions starting July 2011 will be accepted until the positions are filled; however, evaluation of applications will begin by October 1, 2010.

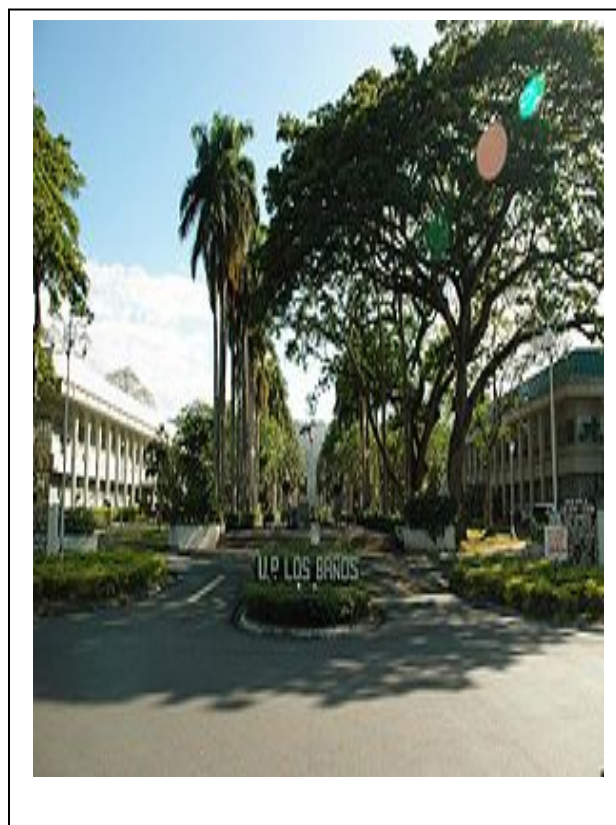

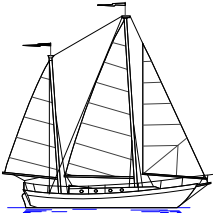
