Pathologists from Uganda, Kenya and Tanzania also reported on the variety of mammalian and avian diseases that are commonly diagnosed in their regions.

The meeting was attended by approximately thirty-five university pathologists, veterinarians and graduate students as well as poultry veterinarians from Ugachick, the largest poultry company in Uganda. Dr. Ojok recorded the speakers on a CD and presented a copy to each participant as a show of appreciation for upcoming projects.

The Southern and Eastern Africa Division of the C.L. Davis Foundation sponsored a three-day symposium at the Equatoria Hotel in Kampala, Uganda in November 2006. The Foundation meeting (now in its sixth year) was organized by Dr. Lonzy Ojok, Director of the Department of Pathology and Faculty of Veterinary Medicine at Makerere University, Kampala. The keynote speakers were Dr. Corrie Brown, University of Georgia, College of Veterinary Medicine, Department of Pathology and Dr. Robert Porter, Wisconsin Veterinary Diagnostic Laboratory and School of Veterinary Medicine, Department of Pathobiological Sciences.

Dr. Brown lectured on the effects of globalization and the pathology of emerging diseases and zoonoses, while Dr. Porter covered the pathology, diagnosis and treatment of a variety of poultry diseases with particular attention to Exotic Newcastle Disease and Avian Influenza.

The 2 x 2 slide collection includes 14,000 kodachromes many of which have been digitalized on laboratory animal diseases and management. Microscopes, Projectors (2x2 and LCD), and VCRs will be available at The Biologic Resources Laboratory.

Facts about the Foundation and US Federal Income Taxes for 2006 and 2007

This column will appear frequently in the Newsletter, as a report by the Chairman of the Board of Directors to the Membership of The Foundation. The Foundation has been designated by the Internal Revenue Service of The United States, as a tax exempt “ Donative Publicly Supported Charity” according to the IRS code of the USA, Sections 501 (c)(3); 509(a)(1) and 170(b)(A) (vi), and as such it *SELLS NOTHING* and is governed by the current Internal Revenue Code of the United States of America. Legally The Foundation is not considered to be a professional organization or society such as the AVMA, ACVP, STP, ACLAM, ASLAP, AAVLD although it collaborates with each of these organizations.

Our Individual and Corporate members and Patrons that reside in the United States will soon commence to prepare their individual or corporate federal income tax returns. Those who itemize their deductions should note that the proper place to take credit for your 2006 contributions to The Foundation is in the listing of your charitable contributions not as a business expense.

Patrons may deduct 100% of their dedicated or non-dedicated 2006 contributions to The Foundation.

Individual members may deduct 100% of their Membership Contributions made during 2006 if they did not request a DVD or CD lecture as a gift providing their check or money order is dated prior to midnight of Sunday, December 31st 2006. If paid by credit card, the credit card receipt must be dated on or before December 31st. If they did accept such a gift they must deduct \$ 5 from the amount of their membership contributions.

Individual members may deduct the Registration Contributions they made during 2006 for each CLD symposium which they attended during the year less \$25 for each day of the symposium in question if morning and afternoon refreshments were served plus \$35 if a course banquet was held. For the CD symposium syllabus and book that was given to each attendee deduct \$10. Your travel and hotel expenses are business expenses

Individual members and Corporate members may deduct the amount contributed to the Publication Division of The Foundation (CLD) for one or more book titles published by CLD.....Less \$5 for each title.

Individual members and Corporate members may deduct the amount contributed to the Faculty Missions Division of The Foundation for one or more of the volumes of the CD and/or

DVD reference libraries published by CLD less \$ 35 per volume.

Individual members and Corporate members may deduct the amount contributed to the World Wide Curriculum Enhancement Division of The Foundation for one or more DVD and/or CD titles published by CLD.....Less \$5 per title.

Patrons, Individuals, Corporate entities or Exhibitors may deduct 100% of the monetary contributions and/or fair market value of materials and equipment (requested by CLD) contributed to the Independent Study Centers Division of The Foundation.

The Foundation has recently written to each of the 865 former members of The Foundation asking each of them for a \$100 contribution to the Faculty Missions Division of The Foundation. For those living in the USA 100% of such a donation is deductible as a charitable contribution on their 2006 income Tax return, providing their check or money order is dated prior to midnight of Sunday, December 31st 2006. If paid by credit card, the credit card receipt must be dated on or before December 31st.

All publications of The Foundation have varied contribution requirements specified to receive the desired publication as a gift from The Foundation. The \$ 5 specified for deduction from your charitable contribution on your tax return represents the cost of materials required for the publication of your gift. It does not represent a sales price since The Foundation *SELLS NOTHING & IS NOT A VENDOR !*

The Pension Protection Act of 2006, passed by the Congress of the USA, encourages IRA account owners who are at least 70-1/2 years of age, to make contributions of up to \$100,000 in 2007 to 501©(3) donative, publicly supported charities, such as The Charles Louis Davis, D.V.M. Foundation, between now and 12/31/2007. Such contributions are excluded from gross taxable income and satisfy the year's minimum distribution from your IRA account. Your IRA custodian must make the charitable transfer directly from your IRA account to the Charles Louis Davis, D.V.M. Foundation and there can be no receipt of any *quid pro quo* by the IRA account owner.....SWT.

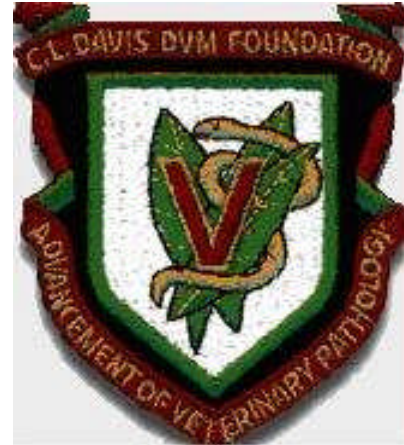
