Davis Foundation Winds Up a Difficult 2009



It's no secret that things are tough all over, and like most charities, 2009 will go down as possibly the toughest economic year ever for the C.L. Davis Foundation. Indicators across the board suggest that the nation's charities will see over a 10% drop in revenues this year, but for a non-endowed charity like the Foundation, which relies exclusively on its membership and course revenues for each year's operating funds, the down economy hits much harder.

"We have been extremely conscious with where we spent money this year," says Foundation president Bruce Williams. "We have had to look extremely hard and cut back in every area – meetings, publications, and faculty travel were cut truly to the bone, and we will make even more changes for 2010. We cut our meetings by half in 2009, and this will probably continue in 2010."

Why such a bleak outlook? Its "natural and understandable," according to Foundation founder and CEO, Sam Thompson. "People are wondering how they are going to pay their bills, or buy Christmas presents," says Dr. Thompson. "Our retired members, or those close to retirement have seen their nest eggs take an unimaginable hit over the last year and a half. Pharmaceutical companies are merging to stay afloat, and for the first time that I can remember, some of our members can't even find jobs. My heart goes out to them." On top of this, add in the budget cuts that have affected veterinary schools across the country, new restrictions on travel and course attendance at many companies, and you can understand the effect it has had on course attendances this year.

But the Foundation and its dedicated volunteers aren't backing down - in fact, volunteerism has reached a whole new level, especially among our dedicated Faculty. "This year has been absolutely amazing," recounts Dr. Williams. "Early this year, I received offers from a number of our faculty members to pay for their own international travel in order to speak for the Foundation. Several said that the Foundation has given them so many opportunities that they wanted to give something back in these tough times."

Many other projects continued despite the lack of incoming funding. Independent study centers around the globe received new lectures on DVD, and we even set up new centers in Argentina, Edinburgh, and India. The 5th edition of John King's

Foundation's Latin Division Has a Busy 2009

From all vantage points, 2009 did not look like it was going to be a good year for the Foundation's international programs. After four annual meetings in Brazil, three in Argentina, and two in Colombia, the Foundation had to consider putting these meetings on hiatus, as we have done in other parts of the world.

However, the Latin Division, headed by Dr. Ingrid Pardo and Foundation Board member Ricardo Ochoa, would not accept that fate. These well-attended meetings are the backbone of the annual convocation of pathologists in those countries and are a great educational source for local trainees who turn out in large numbers.

The Foundation's Latin American Division, (*nee* the Latin Comparative Pathology Group) is a group of dedicated veterinary pathologists originally from countries in Central and South America who seek to increase training and opportunities for pathologists and pathology trainees in this region. On their own initiative, and using their own personal funds, members of the Latin American division traveled to Colombia, Argentina, and Brazil in 2009 to ensure the continuation of these important meetings.

In July 2009, the second annual three-day C.L. Davis symposium was held at the Universidad Nacional with a stellar faculty – Drs. Ingrid Pardo, Marcia Pereira and Ricardo Ochoa (all of whom trained as veterinarians in Colombia, and Brazilian-trained Dr. Ingeborg Langohr. Drs. Fabio del Piero and Srinivas Rao were also part of the delegation – while not “Latin” by strict definition, these two well-traveled Foundation speakers are Latin in spirit and best of all, fluent in Spanish.

With such a stellar cast, this year's Colombian meeting covered all bases - pathology of production animals, lab animals, exotic species, and even toxicologic pathology. Once again, Dr. Carlos Iregui put on an excellent forum, with the attendees agreeing this relatively new course continues to improve with age.

Slightly smaller, but no less enthusiastic groups, traveled to Argentina and Brazil to uphold the Foundation's commitment in these countries as well. Central to the annual meeting of the Argentinian Society of Veterinary Pathology was the two-day symposium put on by Francisco Uzal of UC Davis, Antonio Rodriguez Bertos of the Universidad Complutense de Madrid and once again, Fabio del Piero of the University of Pennsylvania's New Bolton Center. The first day concentrated on systemic pathology of domestic species, including equine respiratory disease, foal diseases, and gastrointestinal pathology of horses, dogs and cats, while the second day of instruction included a number of topics on current methodology of pathology instruction by the assembled participants as well as Foundation Faculty.

A comprehensive overview of veterinary surgical pathology in eight hours! Taught by the renowned Dr. Paul Stromberg from The Ohio State University, this seminar will cover the complete spectrum of biopsy issues from collection of tissue to the wording of the pathology report. Topics in specimen preparation will include instruments for biopsy sample collection, tissue handling, fixation, artifacts, tissue marking, specimen trimming and orientation, margin evaluation, and the submission form. Special attention will be given to effective two-way communication between the clinician and pathologist, cognitive errors in medical diagnosis and looming legal liability issues. Organ systems that will be specifically emphasized are the skin, spleen, and lymph node, and the particular considerations of amputation specimens will also be discussed.

To round out the year, in October, Foundation President Bruce Williams kicked off the 2009 RAPAVE meeting (the biannual meeting of the Brazilian Society of Veterinary Pathologists) in beautiful Aguas de Lindao with a day-long seminar on Descriptive Techniques in Veterinary Pathology, focusing on description in gross, microscopic, and ultrastructural specimens. This biannual conference (alternating in off years with the ANAPAVE in neighboring Argentina) was attended by over 400 veterinary pathologists, many in the early stages of their veterinary pathology careers.

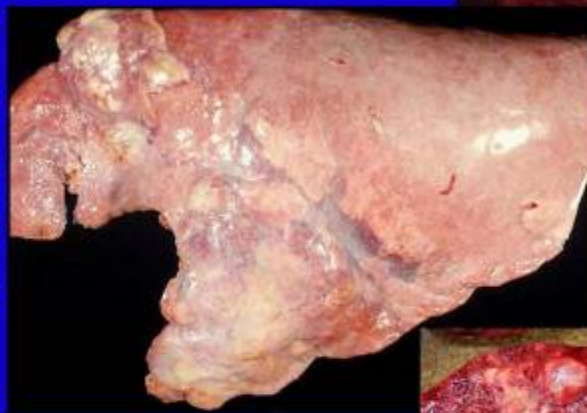
